Amends the Interconnection Agreement between Qwest and New Access Communications, LLC by eliminating UNE-P and implementing batch hot cut processes and discounts.

The amendment amends the interconnection agreement first approved by the Commission on July 11, 2001 in WUTC Docket No. UT-013057 (original docket number).
