- 1 On June 26, 2007, the Washington Utilities and Transportation Commission (Commission) granted provisional operating authority to Allstar Movers, LLC (Allstar Movers) under Permit No. THG-62885. On July 25, 2007, household goods carrier, All Star Transfer, Laron Williams, Inc., d/b/a All Star Moving & Storage (All Star Moving), filed a protest to Allstar Movers’ application for authority. All Star Moving objected to the application, claiming that the two company names are deceptively similar, in violation of Commission rules governing household goods carriers.¹

- 2 On August 21, 2007, the Commission sent Allstar Movers a letter that suspended processing of the application for permanent authority unless and until Allstar Movers changed its company name or received permission from All Star Moving to use the existing name. The letter further stated that Allstar Movers was to respond by September 14, 2007, or the Commission would cancel the company’s provisional authority and dismiss the application for permanent authority. Allstar Movers never responded to the Commission.

- 3 On February 22, 2008, the Commission issued a Notice of Intent to Cancel Temporary Authority and Reject Application For Permanent Authority; Opportunity For Hearing in this matter. The Notice provided Allstar Movers the opportunity to request a hearing or otherwise contest cancellation in writing by March 21, 2008.

- 4 On March 14, 2008, Peter D. Haroldson, counsel for Allstar Movers, filed a Request For Hearing with the Commission in this matter.

5 Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that
a brief adjudicative proceeding is appropriate for resolving the issues in this matter.

6 **NOTICE IS HEREBY GIVEN That a brief adjudicative proceeding will be held
on Monday, April 21, 2008, at 1:30 p.m., in Room 108, First Floor, Richard
Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.**

7 The record in this case will consist of any documents regarding the matter that are
considered or prepared by the presiding officer for the brief adjudicative proceeding.

8 Written notice of any other stage in the proceeding or other formal proceedings that
the Commission may deem appropriate will be given during the course of this case.
The Commission will provide at its offices in Olympia, Washington, copies of
documents in the current record for use by the parties or others who may want to
review them.

9 Parties wishing to submit any other documents for consideration at the brief
adjudicative proceeding must file with the Commission a list enumerating and
describing any such documents no later than 5:00 p.m. on Wednesday, April 16,
2008, and bring an original and three (3) copies to the hearing. Filing shall be in
accordance with WAC 480-07-140 and – 145.

10 THE COMMISSION GIVES NOTICE That any party who fails to attend or
participate in the brief adjudicative proceeding set by this Notice, or any other stage
of this proceeding, may be held in default under RCW 34.05.440.
