Re: Greenhouse Gases Emissions Performance Standard – RCW 80.80 Docket UE-080111

TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made in the Washington Utilities and Transportation Commission's (Commission) rulemaking in Docket UE-080111 to adopt rules to implement the requirements of RCW 80.80.060 regarding electrical company compliance with the greenhouse gases emissions performance standard contained in RCW 80.80.040. This letter also provides notice of an opportunity to file written comments on proposed rules and participate in the formal rule adoption hearing.

On August 20, 2008, the Commission filed a notice of proposed rulemaking (CR-102) in this docket with the Code Reviser. The proposal would govern electrical company filings and process regarding Commission enforcement of the Greenhouse Gases Emissions Performance Standard established by RCW 80.80.040. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
