The Washington Utilities and Transportation Commission (Commission) will accept comments on Pacific Power & Light Company's (Pacific Power or Company) integrated resource plan for electric service. An "integrated resource plan" (IRP or Plan) describes the mix of generation and supply resources and efficiency improvements that will meet both the current and future energy demands at the lowest cost to the utility and its ratepayers.

Pacific Power representatives will present the Plan to the Commission and will respond to questions from the Commissioners and the public at a recessed open meeting of the Commission to be held on **June 25, 2015, at 1:30 p.m.** The meeting will be held at the Commission's headquarters, Room 206, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington. A copy of the plan is on file in the library at the Commission's offices in Olympia. Requests for copies of the Plan should be directed to Pacific Power.

Written comments should be submitted **no later than 5:00 p.m., May 18, 2015**, and, if possible, in electronic format. Electronic format should be on a flash drive, DVD, or CD. Please also send us the text in your choice of .doc (Word 6.0 or later) supplemented by a

separate file in .pdf (Adobe Acrobat) format. Comments may also be submitted via the Commission's Web portal at [www.utc.wa.gov/e-filing](http://www.utc.wa.gov/e-filing) or by electronic mail to the Commission's Records Center at [records@utc.wa.gov](mailto:records@utc.wa.gov).
