4 **Q. Please state your name and business address.**

5 A. My name is Lincoln Webb. My business address is 750 Pandora Avenue,
6 Victoria, British Columbia, V8W 0E4, Canada.

7 **Q. By whom are you employed and in what capacity?**

8 A. I am employed by the British Columbia Investment Management Corporation, as
9 Senior Vice President, Infrastructure and Renewable Resources.

10 **Q. What are your duties as Senior Vice President, Infrastructure and**
11 **Renewable Resources?**

12 A. As Senior Vice President, Infrastructure & Renewable Resources, my
13 responsibilities include leading BCI's private market infrastructure investment
14 program, which has grown to a global portfolio of C\$14 billion since 2004. My
15 team includes a group of 27 professionals who are responsible for the sourcing of
16 investment opportunities, executing on new transactions and monitoring the
17 progress of existing companies in the portfolio. Also, in my role, I am a member
18 of BCI's Executive Management Team, whereby I am involved in setting the
19 strategic direction and overall management of the firm.

20 Currently, I serve on the Presidential and Supervisory Boards of Open Grid
21 Europe—Germany's largest gas transmission utility, and the boards of the Corix
22 Group of companies (North American Utilities), Teays River (International

1 Agriculture and Food), TimberWest Forest Company (Canadian Timberlands),
2 Glencore Agriculture (International Agriculture and Food), Endeavour Energy
3 (Australasian Utility), and Cleco Corporation (a U.S.-based utility).

4 **Q. Briefly describe your education and experience prior to your employment at**
5 **British Columbia Investment Management Corporation.**

6 A. I hold a Masters in Business Administration in International Business, MCP
7 (Architecture), an Advanced Management designation from INSEAD, am a past
8 attendee of management programs at HHL (Germany) and Harvard Business
9 School, and I am a CFA Charterholder.

10 Since 2006, I have been the Vice President of BCI's Private Placements Group
11 and Senior Vice President of the Infrastructure and Renewable Resources Group.

12 During the three years prior to 2006, I was employed in several other roles at BCI
13 including Equities Trader, Assistant Portfolio Manager and Portfolio Manager. I
14 was also an analyst at Boltens Capital in 2001 and a Development Manager at
15 NEICOM Developments from 1998 to 2000.
