Puget Sound Energy (“PSE”) hereby submits, in connection with Docket UG-180861 (Advice No. 2018-43), the following substitute tariff sheets to replace the tariff sheets that were filed initially on October 17, 2018, and substituted on December 17, 2018, and January 4, 2019. This substitute filing is pursuant to RCW 80.28.060 and Chapter 480-80 WAC and includes the following portions of PSE’s tariff for natural gas service:

The purpose of this filing is to provide third substitute tariff sheets reflecting the changes on Sheet Nos. 1171 and 1171-A that PSE committed to make at the Washington Utilities and Transportation Commission (“Commission”)’s Open Meeting on January 10, 2019, in addition to the correction of a typo on Sheet No. 1171-E. PSE worked with the Commission staff to make these revisions.

No tariff change notice was required under the provisions of WAC 480-90-194 or -195, nor required by WAC 480-90-199, nonetheless PSE voluntarily carried out the notice provisions in WAC 480-90-194(2) (a),(b),(d).
