Commission Staff's Response to Request for Payment Arrangement

Dear Ms. Maxwell:

On April 26, 2022, the Washington Utilities and Transportation Commission (Commission) issued a penalty assessment against Vicky Sandhu d/b/a Seattle Top Class Limo; Alisha Limousine Service; Seattle Party Bus Limo, (Seattle Top Class Limo or Company) in the amount of \$5,400 for violations of Washington Administrative Code 480-30-221, Vehicle and Driver Safety Requirements.

On May 6, 2022, the Commission imposed the \$2,500 suspended penalty issued in Docket TE-190932, due to a repeat violation of acute regulations.

On July 15, 2022, the Commission entered Order 01 in Docket TE-220239, denying the Company's mitigation request. Order 01 further suspended a \$1,500 portion of the penalty for a period of two years before being waived, subject to conditions. Order 01 required the Company to pay the \$3,900 portion of the penalty that is not suspended within 10 days.

On July 28, 2022, Commission staff (Staff) and Seattle Top Class Limo came to a mutual agreement on a proposed payment plan covering the total imposed \$6,400 penalties, as follows:
