On March 10, 2025, Avista Corporation d/b/a Avista Utilities (Avista), filed with the Washington Utilities and Transportation Commission (Commission) a draft 2025 All-Source Request for Proposals (RFP) for approval by the Commission, as specified in WAC Chapter 480-107. **2025 Avista All-source RFP – Preliminary Public Participation Schedule**

Guided by these requirements, a preliminary public participation schedule is provided below, and may be revised as needed.

May 22	Last regularly scheduled Commission open meeting during 75-day Commission review period.
