RE: Rulemaking to Consider Adoption of Rules to Implement RCW 80.54, Relating to Attachments to Transmission Facilities, Docket U-140621

TO ALL INTERESTED PERSONS:

This letter informs you of the progress made in this rulemaking docket concerning the possible adoption of chapter 480-54 WAC to implement chapter 80.54 RCW governing attachments to utility transmission facilities. This letter also provides notice of an opportunity to file written comments on the proposed rules and to participate in the formal rule adoption hearing scheduled for 9:30 a.m. on Thursday, September 17, 2015.

On July 22, 2015, the Washington Utilities and Transportation Commission (Commission) filed a Notice of Proposed Rulemaking (CR-102) with the Office of the Code Reviser. The proposed rules would implement chapter 80.54 RCW, relating to attachments to transmission facilities. The Commission has reviewed comments received from stakeholders received to date in this docket and has prepared proposed rules for review and comment by interested persons. The proposed rules are available for inspection on the Commission's web page at www.utc.wa.gov/140621. The CR-102 filing initiates the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
