First, I would like to thank the WUTC for moving its headquarters to be much more accessible to all, being far nearer to I-5, and having much more parking for anyone from thruout the state seeking to attend your meetings. This includes myself. I can now easily walk over from my home in far East Olympia to your meetings, to get my daily dose of both physical and intellectual exercise, while parking myself in your more commodious new chambers to more often be your guest! And I am certain that this prospect will occasion squeals of delight in both the WUTC Commissioners and staff! Second, I would also like to thank you for now having more open meetings for all Washingtonians, including myself, to attend and give our input into your regulatory process. And, as former telecom/energy industry lawyers and executives, your have the know-how and connections – as well as the requisite revolving door -- to maximize the benefits to yourselves, as well as to your actual corporate constituents – as opposed to us, your purported constitutional constituents.

COMMISSION This is very similar to the FCC Commissioners – almost all of whom are also former telecom industry lawyers and executives -- seeking with the telecom industry from the federal level to impose even more dangerous weaponized 5G wireless on the American people -- just as you have sought with the investor-owned energy industry to impose weaponized "smart" utility meters on the people of Washington State, using the foundations of over forty years of federal and state corporate government-enabled telecom and energy industry financial and material fraud, collusion and conspiracy.

This federal and state corporate government-enabled racketeering is now in the process of being publicly exposed, and will soon begin to be penalized, starting with the trillion-dollar class action lawsuit against the FCC for its weaponized 5G imposition being joined by over sixty municipalities and their related associations nationwide – including seventeen municipalities right here in Washington State, among which Thurston County and its county seat, the Washington State capital city of Olympia and its largest suburb, Lacey, number. Such conventional court cases are also about to be augmented by parallel cost-effective, mass out-of-court administrative contract law-based legal actions: these are called Notices of Liability, and they are about to be filed by many thousands – and eventually – by possibly millions of people, both nationally and worldwide.

These Notices of Liability will hold corporate governments, and their client commercial corporate officials financially liable, in both their personal and official capacities. We the people will stand together to take back our power from those who have for so long used this power we had so naively entrusted to them to serve the public, only to serve themselves and their client corporate interests. We therefore strongly suggest that the Washington State Utilities Corporation reconsider its support for weaponized "smart" utility meters, as well as, at the very least, pass a public resolution supporting those now seeking to stop far more dangerous weaponized 5G wireless, even as these litigants in so doing also seek to stop federal usurpation of the constitutional rights of US state and local governments, as well as of the American people, by way of present and future actions of law – both within the courts and without them.
