Description of amendment: This amendment incorporates certain agreements (referenced in the attached document) which were previously approved as Amendments in WUTC Docket No. UT-980312 into the current Qwest and Covad Interconnection Agreement in Docket No. UT-043045.

The amendment amends the interconnection agreement first approved by the Commission on June 6, 2005 (date) in WUTC Docket No. UT-043045 (original docket number).
