My name is Cindy Kisska. I live in Birch Bay, WA. I have been an electric PSE customer for the past 18 years. I am one person, but I know I speak for thousands of people across the state of WA.

How is it that <u>PSE is SO-O CORRUPT</u> and the courts are STILL entertaining the thought to even listen to anything PSE even has to say? <u>How many lies does PSE have to tell before they are stopped</u>? Their behavior is criminal. If PSE was a singular person – they'd be locked up already for all their criminal behavior. What is it going to take to stop PSE? I am shocked that the <u>UTC STAFF</u> every year <u>recommends allowing PSE to raise our electric rates: BASED ON PSE'S FALSE FINANCIAL INFORMATION AND CONSTANT LIES AND DECEIT, SO PSE CAN SHARE THEIR WEALTH WITH THEIR SHAREHOLDERS—INSTEAD OF WITH THEIR CUSTOMERS TO LOWER OUR RATES.

Does any one even remember that PSE is a <u>Utility Company</u>, and that <u>the UTC was originally formed TO PROTECT THE UTILITY COMPANY'S CUSTOMERS</u>? Why is the UTC staff <u>complicit</u> in all of this,</u>

Let's examine this statement: "In the end, the Commissioners must ensure that rates are fair, just and reasonable for ALL INTERESTS involved."

- This word "interests" should **NOT** be used in the same sentence when referring to Shareholders and Customers, BECAUSE the meaning is <u>completely opposite</u> for each one.
- The Shareholder's "interests" are vastly different from the Customer's "interests"/needs.

- Customer "interests" actually refers to Customer's "Needs" the need to stay warm in the winter and still be able to afford their PSE electric bills.
- While Shareholder's "interests" means how much money (profits) they can make. In other words, the already wealthy, becoming wealthier.
- Under this context, PSE raising their customer rates every year is NEITHER FAIR, JUST, NOR REASONABLE. The wealthy don't need protection, but the poor and vulnerable do.

The UTC STAFF does not have a LEGAL leg to stand on when it recommends to the Commissioners to allow PSE to raise our electric rates, based on PSE's constant lying about their finances – LIES ARE NOTHING MORE THAN THIN AIR – they have absolutely NO REALITY to them. Truth is facts. PSE no longer has any facts on their side, to hold them up. Their whole foundation now is nothing but lie, after lie, after lie. It is a complete sham to even allow PSE in a courtroom to present their "side" of the story – when that is ALL it is – just a made-up fabricated story – a puzzle with most of its pieces missing because PSE refuses to submit any real facts concerning how they operate – BECAUSE they no longer have any real facts on their side to support them.

The <u>only real fact</u> is PSE are <u>constantly lying</u>. This was clearly revealed in Richard Lauckhart's testimony. Lauckhart told the Judge, "CENSE MADE <u>56</u> data requests in this proceeding." The OAG and the UTC are supposed to <u>truly listen</u> AND <u>truly HEAR</u> what we, the people recommend to the UTC EVERY SINGLE YEAR: PLEASE DO NOT ALLOW PSE TO RAISE OUR RATES AGAIN! But instead, our cries for help ALWAYS FALL ON DEAF EARS. WHY IS THAT? CAN ANY ONE EXPLAIN? ESPECIALLY WHEN OUR UTILITY COMPANY – PSE – HAS TURNED INTO A PROFITCHURNING MACHINE THAT EXISTS ONLY FOR ITS SHAREHOLDERS.

SOMEONE NEEDS TO STAND UP FOR US, THE PSE CUSTOMER <u>AND</u> THE UTC COMMISSIONERS....I BELIEVE THEY SINCERELY CARE....BUT THEIR HANDS ARE TIED UNDER THE PRESENT CIRCUMSTANCES.
