Notice of the Application was published in the Commission's weekly Docket of January 31, 2005.
- 2 The Application requests authority to provide door-to-door passenger service, by reservation only, between points in King, Snohomish, and Pierce Counties and the Seattle-Tacoma International Airport. All passengers must have Seattle-Tacoma International Airport as an origin or destination. The Applicant has filed proposed tariffs and schedules describing the conditions under which it intends to provide the service it proposes.
