## TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made in the Washington Utilities and Transportation Commission's (Commission) rulemaking in Docket A-091124, specifically WAC 480-120-999, Adoption by reference. This letter also provides notice of an opportunity to file written comments on the proposed rule and participate in the formal rule adoption hearing.

On October 7, 2010, the Commission filed an expedited rulemaking (CR-105) in this docket with the Code Reviser setting a deadline of December 8, 2009, for interested persons to submit written comments on proposed revisions to the adoption-by-reference rules in Title 480 WAC. The Commission received one written comment related to WAC 480-120-999. Under the expedited rulemaking statute, RCW 34.05.353, if a written notice of objection to the expedited rulemaking is timely filed and is not withdrawn, the notice of proposed expedited rulemaking is considered a statement of inquiry (CR-101). That means that a portion of this rulemaking cannot proceed on an expedited basis. However, to allow the other rules noticed in the CR-105 to go forward without delay, the Commission has adopted by separate order the rules noticed in the CR-105 with the exception of WAC 480-120-999<sup>1</sup>, which will continue to be considered in this docket according to the standard rulemaking

process (CR-102). A summary/matrix of the comment received is posted to the UTC's web site at www.utc.wa.gov/091124.

On January 20, 2010, the Commission filed a CR-102 in this docket with the Code Reviser. This action begins the final part of the rulemaking process concerning WAC 480-120-999, which includes a written comment period, a public adoption hearing, and a decision by the Commission.

THE COMMISSION GIVES NOTICE of your opportunity to submit written comments on the proposed rule by filing with the Commission Executive Director and Secretary either by electronic transmission as described below, or by physical delivery to 1300 S. The Commission will send you a paper copy of the proposed rule or will send the proposal via electronic mail, if you ask.
