Dear Mr. Johnson:

Puget Sound Energy (“PSE”) hereby submits, in connection with Docket UE-180086, the following substitute tariff sheets to replace Sheet No. 62-A submitted on May 11th and Attachment “C” submitted on May 17th. The initial filing of this docket was submitted on January 26, 2018, under the PSE’s Advice No. 2018-05. This fourth substitute filing is pursuant to RCW 80.28.060 and Chapter 480-80 WAC and includes the following portions of PSE’s tariff for electric service:

WN U-60, Tariff G - (Electric Tariff):
2nd Revision of Sheet No. 62-A - Substation and Related Equipment Capacity (Continued)
Attachment “C” to Schedule 62 - Rate Methodology

The purpose of this substitute tariff filing is to incorporate additional changes to these tariff sheets and the work paper at the request of the WUTC Staff on May 18, 2018.

The annual revenue from this Schedule 62 electric substation and related equipment leasing service is about \$4 million associated with approximately \$26 million in net leased plant. The estimated overall annual decrease in customer bills is \$346,359. All Schedule 62 customers except one would experience a bill decrease due to the proposed changes in Schedule 62 rates.

The tariff sheets described herein reflect an issue date of January 26, 2018, and an effective date of June 1, 2018. Posting of proposed tariff changes, as required by WAC 480-100-193, is being made by posting the proposed tariff sheets on the PSE web site immediately prior to or coincident with the date of this transmittal letter. PSE is in the process of notifying each
