**RATE INCREASE NOTICE FOR THURSTON COUNTY BELOW 142<sup>ND</sup> AVENUE RESIDENTIAL YARD WASTE**

Dear Customer:

July 31, 2020

Harold LeMay Enterprises, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC November 1, 2010. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, truck equipment and has purchased additional capital assets.

If approved by the WUTC, the proposed rates below will become effective September 1, 2020.

Yard waste service	9.65	1.57	11.22
Other yard waste services not listed will increase an average of 16.32%			

If you have any questions regarding this increase, please contact Harold LeMay Enterprises, Inc. between 8 a.m. and 5 p.m. Monday through Friday.

The Commission has the authority to set final rates that may be either lower or higher from the company's request, depending on the results of its investigation. Commission staff will make a recommendation to the Commissioners at an open meeting which is scheduled for 9:30 a.m. on August 27, 2020. The UTC building is closed to the public until further notice.
