Puget Sound Energy ("PSE") hereby submits in connection with Docket UG-230756 the following revised WN U-2 Natural Gas tariff sheets in addition to the tariff sheets that accompanied its September 15, 2023 filing, submitted under Advice No. 2023-40.

WN U-2 - (Natural Gas Tariff):

The purpose of this substitute filing is to extend the amount of time in which a customer may provide evidence that they are a registered Covered Entity, Opt-In Entity, National Security Entity or EITE that is also either a Covered Entity or an Opt-In Entity from within 90 days of the initial effective date of Schedule 111 to 150 days of the initial effective date of Schedule 111. This will allow customers more time to work with the Department of Ecology to obtain and provide such evidence. Additionally, this substitute filing updates the Definitions section of Schedule 111 to include the definition of Opt-In Entity, which was included in the Company's initial filing proposing Schedule 111 on June 9, 2023¹, but was inadvertently removed when the Company made a substitute filing on July 31, 2023.

The tariff sheets described herein reflect an issue date of September 15, 2023, and effective date of November 1, 2023. Posting of proposed tariff changes, as required by WAC 480-90-193, is being accomplished by posting the proposed tariff sheets on the PSE web site coincident with the date of this transmittal letter.
