Puget Sound Energy ("PSE") hereby submits in connection with Docket UG-210194 revised tariff sheets to replace the tariff sheets that accompanied PSE's March 22, 2021 filing submitted under PSE's Advice No. 2021-07. This substitute filing includes the following portion of PSE's WN U-2 Tariff for natural gas service.

The purpose of this substitute filing is to extend the effective date of PSE's proposed tariff sheets to May 22, 2021, subsequent to the Commission's request at its Open Meeting today. Accordingly, the availability date of the service has been extended to the following month of November, 2021. In addition, language in the Cost Recovery section has been amended to clarify PSE's original intention of seeking recovery of start-up costs in its next general rate case.

The tariff sheets described herein reflect the original issue date of March 22, 2021 and a revised effective date of May 22, 2021. Posting of this substitute filing for public inspection and review, as required by law and the Commission's rules and regulations, is being completed in accordance with WAC 480-90-193(1).
