PacifiCorp dba Pacific Power & Light Company (PacifiCorp) submits its 2021 Power Cost Adjustment Mechanism (PCAM) filing. Included in this filing is the direct testimony and exhibit of Jack Painter, supporting workpapers, and a petition to alter the amortization of the PCAM surcharge from one year to two years to mitigate the rate impact to customers.

Disclosure of such information would harm PacifiCorp by an unfair competitive disadvantage.
