Dear Mr. Curl:

The purpose of this letter is to request that the Commission send a letter to the parties asking for a waiver of objection to Mr. Merton Lott's participation in the above-referenced proceeding on behalf of Commission Staff. In 1993, Mr. Lott participated as an advisor to the Commissioners in the rate case filed by Washington Natural Gas Company in Docket No. UG-920840.

Prior to June 1, 1996, Mr. Lott was employed by the Commission as its Accounting Advisor. In that role, he advised the Commissioners and the Administrative Law Judge on Washington Natural Gas Company's request for a general rate increase totaling \$14.8 million in Docket No. UG-920874. On June 1, 1996, Mr. Lott assumed his present duties as Gas Program Coordinator. In his current position he works with Commission Staff, which presents cases



before the Commission or Administrative Law Judges in adversarial proceedings. The Staff of the gas program is currently participating in a review of Puget Sound Energy's Petition for Rehearing in Docket No. UG-920874.
