The Washington Natural Gas Company filed in Docket No. UG-940034 on January 7, 1994, its amendment to Schedule 50 relating to sales of compressed natural gas for vehicle fuel. That filing was in compliance with the Sixth Supplemental Order entered in this docket on December 8, 1993. The operation of the tariff revisions has been suspended by order of the Commission in this cause pending hearing or hearings concerning such changes and the justness and reasonableness thereof.

Hearing in this matter is being held pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.422, 34.05.440, 34.05.449 and 34.05.452. The Commission has jurisdiction over this matter under Title 80 RCW, having legal authority to regulate the rates, services, and practices of gas companies under chapter 80.04 RCW and chapter 80.28 RCW, including but not limited to RCW 80.04.250, RCW 80.28.010, RCW 80.28.020, RCW 80.28.050, RCW 80.28.090, RCW 80.28.100, and RCW 80.01.040. In addition to the foregoing statutes, rules involved include those within chapter 480-09 WAC, including WAC 480-09-480, and chapter 480-90 WAC. The ultimate issues involved are whether the tariff revisions are just, reasonable, and sufficient and in the public interest. The issue as to the justness, reasonableness, and sufficiency of the rates includes consideration of alternative rate design or structure. In accordance with the provisions of RCW 80.04.130 the burden of proof to show that the tariff revisions are just and reasonable will be upon the respondent.

NOTICE IS HEREBY GIVEN That a prehearing conference herein will be held at the hour of 1:30 p.m., Wednesday, August 10, 1994, in the Commission's Hearing Room, Second Floor, Chandler Plaza Building, 1300 S. Evergreen Park Drive SW, Olympia, Washington. The time and place for the evidentiary hearings will be set at the

prehearing conference or by later written notice. The purpose of said prehearing conference is to consider formulating the issues in the proceeding and determining other matters to aid in its disposition, as specified in WAC 480-09-460. Respondent will be expected to have available at that time for distribution to all parties and interested persons copies of the direct testimony and exhibits that they propose to present. Those documents will at that time be marked as exhibits. Appearances will be taken. Petitions to intervene should be made in writing prior to that date or made orally at that time.

Please see the form attached to this notice which should be filled out and returned if any party or witness needs an interpreter or other assistance.

NOTICE IS FURTHER GIVEN THAT ANY PARTY WHO FAILS TO ATTEND OR PARTICIPATE IN THE PREHEARING CONFERENCE SET HEREIN, OR OTHER STAGE OF THIS PROCEEDING, MAY BE HELD IN DEFAULT IN ACCORDANCE WITH THE TERMS OF RCW 34.05.440.
