RE: Application to Amend Certificate of Public Convenience and Necessity

Dear Mr. Johnson:

Enclosed pursuant to RCW 80.28.190, please find an application to amend Cascade Natural Gas' ("Cascade") Certificate of Public Convenience and Necessity.

With this application, Cascade is requesting to add to its certificated area designated portions of Skagit, Benton, Franklin, Kitsap, and Walla Walla Counties that are contiguous to presently certificated areas. In the course of updating maps of Cascade facilities, it was discovered that some facilities had been inadvertently constructed pursuant to customer requests outside the borders of Cascade's existing certificated territory. The proposed amendments to Cascade's certificate will resolve that situation. Provided herewith are maps of both Cascade's current certificated areas and the proposed areas. These areas comprise sections which will amend the boundaries of the following Appendices:

Northeast and South Mount Vernon and Sedro-Woolley (all in Skagit County) Appendix A-2
Poulsbo (Kitsap County) Appendix A-4
Wallula (Walla Walla County), Pasco (Franklin County), and Richland (Benton County) Appendix A-12
Paterson and Plymouth (both in Benton County) Appendix A-11
