Please refer to previous orders and investigations specifically the "Glacier" and "T&T" where "incidental" was abused, and look at the discussion/order on the meaning of "incidental." I also believe that the collection of the solid waste tax may also be a lead to be pursued. That tax is only collected on the collection or disposal of solid waste, and then remitted to the DOR, usually "other" businesses collect a sales tax and not the solid waste tax.

Hello Brad -- Sorry for not responding sooner.

Thank you for bringing this to our attention. Nothing in the UTC's statutes says that a company is subject to regulation simply because it pays the solid waste tax. The commission does not regulate all companies that collect and transport solid waste - see WAC 480-70-011, Exempt Operations, and specifically:

(g) The operations of private carriers who, in their own vehicles, transport solid waste purely as an incidental adjunct to some other established private business owned or operated by them in good faith. This private-carrier exemption does not include persons transporting solid waste from residential sources, such as apartment houses or mobile home parks, in vehicles designed or used primarily for the transport of solid waste;

1-800-Got-Junk is a franchise operation so there are many different operators throughout the state. We understand that each franchisee could provide different services, some of which may make them subject to regulation. Staff has reviewed several companies' operations and concluded they were not subject to regulation. However, even if that included some 1-800-Got-Junk franchisees, it may not be appropriate to apply that same conclusion to all 1-800-Got-Junk franchisees.

To determine if this franchisee is subject to regulation, our next step is to contact the company to request a description of the services that it provides. We will evaluate the information we receive to determine if further action is warranted.
