Puget Sound Energy (“PSE”) hereby submits in connection with Docket UE-220066 a tariff sheet to be included with the tariff sheets that accompanied PSE’s December 27, 2022 filing submitted under PSE’s Advice No. 2022-29. This substitute sheet filing includes the following proposed portion of PSE WN U-60, tariff for electric service:

The purpose of this substitute filing is to correct the PCA Surcharge/Refund Rate on Sheet No. 95-E.10. The sum of this and the Monthly Rate on Sheet No. 95-C.3 make up the entirety of the rate for customers on Schedules 51 and 53 – Smart LED Light Charges. Although customers have been billed correctly, the two rates were inadvertently transposed in PSE’s Schedule 95 filing under in Docket UE-220890. PSE’s Compliance filing under Docket UE-220066 will set the Monthly Rate on Sheet No. 95-C.3 to zero and retain the Supplemental Rate which begins on Sheet No. 95-E of the schedule. This substitute filing corrects the Supplemental Rate.

The tariff sheet described herein reflects an issue date of December 27, 2022, and an effective date of January 5, 2023. Posting of the proposed tariff changes for public inspection and review, as required by law and the Commission’s rules and regulations, is being completed in accordance with WAC 480-100-193(1).
