# RATE SCHEDULE 42 LARGE VOLUME NON-RESIDENTIAL SALES AND TRANSPORTATION SERVICE

# AVAILABLE:

To Non-Residential Customers in all territory served by the Company under the Tariff of which this Rate Schedule is a part. No seasonal or temporary Discontinuance of Service is permitted. Customer may be required to pay the Company, in advance, for costs related to the Company's installation of any Distribution Facilities necessary to provide service to Customer under this Schedule. See **SCHEDULE E**.

# **SERVICE DESCRIPTION:**

Service under this Rate Schedule is one or any combination of Firm Sales, Firm Transportation, Interruptible Sales or Interruptible Transportation Service on the Company's Distribution System. The Company may require that Company-owned telemetry equipment be installed at Customer's Premise, subject to charges set forth in **SCHEDULE 10**. Transportation Service under this Rate Schedule is subject to the Terms and Conditions set forth in **S**CHEDULE **T** of this Tariff. Interruptible Service under this Rate Schedule is subject to Curtailment under the Terms and Conditions set forth in **R**ULE **16**.

# PRE-REQUISITES TO SERVICE:

- 1. An Automated Meter Reading device (AMR) must be installed at the premise, and Customer must provide active and continuous telephone service to such meter(s).
- 2. Customers that elect Transportation Service must be able to receive notices via automatic electronic means acceptable to the Company.

#### **INITIAL TERM AND CHANGES TO SERVICE ELECTIONS:**

The initial term of service under this Rate Schedule shall commence effective July 1, 2004, except that during the initial transition period, July 1, 2004 through June 30, 2005, Customer may make a one-time change to their service election at any time upon one billing month advance notice. Any such change will initiate a new one (1) Year term of service.

#### TERM OF SERVICE:

The Term of Service under this Rate Schedule is one (1) Year. At the end of a full Term of Service, service under this Rate Schedule will continue on a monthly basis until terminated by either the Customer or the Company upon one (1) billing month advance notice.

#### **SERVICE ELECTIONS:**

Customer may not change service elections until a full Term of Service has been completed. Thereafter, the combination of services elected by the Customer may be changed at any time upon providing one (1) billing month advance notice to the Company. Any change in the Customer's service election under this Rate Schedule will initiate a new Term of Service.
