Dear Ms. Washburn:

The Fragaria Landing Water Company, Inc. (Fragaria) revised procedural schedule (Order 04) calls for Commission staff (Staff) to file testimony on October 18, 2006. Staff and Fragaria are continuing to work productively towards settlement of remaining issues. Once the parties reach a settlement in principle, the parties will need to subsequently reduce it to writing.

Accordingly, the parties believe that at this time it would present an unnecessary additional burden to simultaneously file testimony while engaging in these negotiations. Having discussed this matter with Fragaria, Staff respectfully requests that the schedule be amended to allow additional time for the parties to continue negotiations in anticipation of a settlement. Fragaria has agreed to this revision to the case schedule. Please see the attached proposed revised schedule. The parties will keep the Commission informed as to the progress of settlement. Thank you for your consideration.

¹ The proposal does not include a final order deadline, consistent with schedules in prior Orders 02 and 03. Order 04 extended, for cause, a deadline for issuing a final order, citing RCW 80.04.110(3) [requiring entry of final order within ten months from the date of complaint unless extended for cause]. It is the parties' understanding that this requirement applies to complaints filed by an "entity or person other than the commission". Because this is a Commission-filed complaint, the parties suggest that the requirement does not apply to this docket. Nevertheless, the parties have no objection to extending a final order deadline to allow for the revised schedule if the Commission finds it appropriate to set a final order deadline in this docket.
