
For the following reasons I feel we have the right to use the name NORTHWEST ALL STAR MOVERS:

On August 12, 1997, application P-78664 was filed by Northwest All-Star Movers, Inc., d/b/a Laron Williams All-Star Moving and Storage, under the provisions of chapter 81.80 RCW, for temporary authority to operate the rights under Common Carrier Permit No. CC-5724, standing in the name of Northwest Cartage Co., pending transfer under application P-78665.

The Commission having considered the application for temporary permit authority finds that it meets the requirements for grant of a temporary permit to operate the rights of an existing permit, pending decision on a transfer of that authority, under the provisions of WAC 480-12-033. The applicant has demonstrated in conversations and meetings with Commission staff that he has both the ability and commitment to work within the regulatory framework to supply service to those members of the public wishing to employ the services of a transporter of household goods. In addition, the current holder of the permit has provided statements to the Commission indicating that the value of the permit would be adversely impacted were the applicant not allowed to operate it during the period until a decision can be rendered in the application for permanent transfer of the authority.

However, the Commission also finds it appropriate that this grant of temporary common carrier authority be subject to special terms and conditions. Imposition of special terms and conditions in the granting of temporary permits is authorized by WAC 480-12-033(5). The Commission imposes these conditions because:

- (1) the applicant has in the past operated as an illegal carrier, transporting household goods without having first obtained authority from the Commission to do so;
- (2) the applicant has operated the permit of another carrier without having first obtained Commission approval of that transaction; and
- (3) the application for temporary authority was protested by All Star Moving, Inc. of Veradale, Washington, because of potential confusion of the part of the shipping public due to the similarity in the names of the two companies.
