## TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made in this rulemaking docket concerning possible adoption of proposed revisions to household goods carrier entry and fitness standard rules. This letter also provides notice of an opportunity to file written comments on the proposed rule amendments and to participate in the formal rule adoption hearing scheduled for 1:30 p.m. on Thursday, April 26, 2012.

On March 7, 2012, the Washington Utilities and Transportation Commission (Commission) filed a Notice of Proposed Rulemaking (CR-102) in this docket with the Code Reviser regarding entry and fitness standards for household goods carriers. The Commission developed the proposed rules revisions with the benefit of stakeholder comments received on September 26, 2011, and on December 9, 2011, and during the stakeholder workshop held on October 11, 2011, which are available in this docket on the Commission's website <a href="http://www.utc.wa.gov/111493">http://www.utc.wa.gov/111493</a>.

The CR-102 begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.

Additionally, upon request, the Commission will send you a paper copy if needed.
