TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made in this rulemaking docket concerning possible adoption of proposed revisions to household goods carrier entry and fitness standard rules. This letter also provides notice of an opportunity to file written comments on the proposed rule amendments and to participate in the formal rule adoption hearing scheduled for 1:30 p.m. on Thursday, April 26, 2012.

On March 7, 2012, the Washington Utilities and Transportation Commission (Commission) filed a Notice of Proposed Rulemaking (CR-102) in this docket with the Code Reviser regarding entry and fitness standards for household goods carriers. The Commission developed the proposed rules revisions with the benefit of stakeholder comments received on September 26, 2011, and on December 9, 2011, and during the stakeholder workshop held on October 11, 2011, which are available in this docket on the Commission's website <http://www.utc.wa.gov/111493>.

The CR-102 begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.

THE COMMISSION GIVES NOTICE of your opportunity to submit written comments on the proposed rules to the Commission by filing with the Commission Executive Director and Secretary either by electronic transmission as described below, or by physical delivery to 1300 S. Evergreen Park Drive S.W., P.O. Box 47250, Olympia, Washington, 98504-7250, no later than 5:00 p.m., Monday, April 9, 2012. The proposed rules, as filed with the Code Reviser, are available for inspection on the Commission's web site at <http://www.utc.wa.gov/111493>. Additionally, upon request, the Commission will send you a paper copy if needed.

Electronic copies: The Commission asks that you provide your comments in electronic format to enhance public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations from the comments. You may submit comments via the Commission's Web portal at <http://www.utc.wa.gov/e-filing> or by electronic mail to the Commission's Records Center at records@utc.wa.gov.

- The title and date of the comment or comments
