**RE: Notice of Intent to Send to Collections, Penalty Assessment No. TV-140342**

Dear Mr. and Mrs. Allen:

As you are aware, on May 7, 2014, the Washington Utilities and Transportation Commission (Commission) entered Order 02, Stipulated Initial Order Classifying Respondent as Household Goods Carrier; Ordering Respondent to Cease & Desist; Imposing and Suspending Penalties on Condition of Future Compliance (Order 02). Order 02 ordered you to cease and desist operating as a household goods carrier and imposed a fine of \$5,000 for two violations of RCW 81.80.075(1), all but \$500 of which was suspended for a period of two years from the date of Order 02, conditioned on the Company refraining from operating as a household goods carrier without a permit from the Commission and paying the assessed penalty of \$500 that was not suspended.

Commission records indicate that Eastside made full payment of the \$500 penalty amount that was not suspended. However, on June 13, 2014, Commission Staff filed a letter stating that Eastside continues to operate as a household goods carrier without a permit in violation of Order 02, and has therefore failed to fulfill the conditions under which the Commission suspended \$4,500 of the assessed penalty. That penalty amount is now due and payable. The Commission sent you a Final Notice on January 14, 2015.

The Commission has not received the \$4,500 payment due and owing.

**This is to notify you that the Commission intends to forward your outstanding debt to a collection agency for collection.** You likely will incur additional expenses and fees, including costs of collection, attorney's fees, and interest. These expenses and fees will be added to your outstanding \$4,500 balance.
