Skyline Telecom Inc. submits the following documents per the requirements of Docket UT-190641:

1. **REVISED** (now is dated) Affidavit attesting to the detail contained in the proposed project
2. Detailed Project Budget
3. An officer approved capital budget for 2020.

This project is considered Phase 1 of a 3 Phase fiber to the home build-out. In Phase 1 Skyline Telecom, will provide fiber to the home to 14 locations. This budget provides for the construction labor, fiber, conduit and the electronics necessary to provide both telephone and internet to each of the 14 locations. As bandwidth requirements continue to increase, copper-based plant can be restrictive. Loop lengths and quality of the copper must be considered when determining bandwidth availability at each location. With the deployment of fiber, these limitations will no longer be a hurdle in the ability to offer high-speed broadband.


