The notice that was mailed out on June 29th did not include the rate table below. We apologize for the confusion that this may have caused. Harold LeMay Enterprises, Inc. has filed a request for a rate change with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC June 1, 2018. Since that time, the Company has invested in new capital and experienced increases in operating costs in the areas of labor, employee benefits, fuel, parts and equipment amongst other categories which it now seeks to update in rates.

Additionally, the Company is seeking to recover incremental COVID-19 costs over a two year period. If this filing is approved by the WUTC, the COVID-19 cost recovery period will be August 1, 2021- July 31, 2023.

If approved, the proposed rates will become effective August 1, 2021. The rate per month will increase as follows:
