Re: UG-230819 – Washington Climate Commitment Act ("CCA") Cost Recovery Mechanism – Corrected Amended Tariff Sheet – DO NOT REDOCKET

On October 4, 2023, Northwest Natural Gas Company, dba NW Natural ("NW Natural" or "Company") filed Advice No. 23-14, docketed as UG-230819, to propose new tariff Schedule 308, Washington Climate Commitment Act Recovery Mechanism. Subsequent filings to amend the proposed tariff Sheet 308-2 were filed on November 16 and November 29, 2023. After the November 29 filing, it was discovered that the amended tariff Sheet 308-2 had included the incorrect issuance date. This filing corrects the issuance date of proposed tariff Sheet 308-2 to indicate an issuance date of October 4, 2023.

Purpose

The purpose of this filing is housekeeping in nature – to provide a replacement page for proposed tariff Sheet 308-2 to reflect the correction of the issuance date as described above. All other proposed tariff sheets previously filed in this docket remain unchanged.

Conclusion

The Company respectfully requests that the replacement tariff sheets filed herewith be approved to become effective with service on and after January 1, 2024.
