INTRODUCTION

Qwest Corporation (“Qwest”) submits a revised Qwest Performance Assurance Plan (“QPAP”) Exhibit K for Washington to modify the QPAP, to reflect changes agreed to by Staff for the elimination of the requirement to submit paper copies of the monthly CLEC performance results to the Commission.¹

DESCRIPTION OF CHANGES

This submission results from discussions with Commission Staff concerning the requirement in Section 14.2 for Qwest to submit monthly CLEC performance results in both paper and electronic forms. Those discussions produced agreement between Qwest and Staff that the requirement to submit paper copies of the reports was unnecessary for the work of the

Commission to monitor Qwest's performance under the QPAP. This agreement produced a concurrence that Qwest should file this notice that will if approved, eliminate the requirement to submit monthly paper copies of the reports. The electronic copies of the reports will be submitted as agreed to with Staff.

A. QPAP Changes

The revised Exhibit K reflects in Section 14.2 the elimination of the requirement to file monthly paper copies of the CLEC performance results with the Commission but leaves unchanged the requirement to submit the results in electronic form to the Commission as well as Public Counsel. Qwest respectfully requests that the Commission issue its order permitting the changes to become effective.

Conclusion

By making this filing in Docket No.UT-003022, Qwest requests that the Commission approve the QPAP, as revised and modified. Further, Qwest requests pursuant to Section 16 of the QPAP, that the changes shall automatically apply to all existing interconnection agreements that currently contain the QPAP, Exhibit K as an exhibit.

REQUESTED RELIEF

Qwest respectfully requests that the Commission permit the amended Exhibit K to go into effect in accordance with 47 U.S.C. § 252(f)(3).

Qwest submits this notice in the two dockets captioned above. Pursuant to section 16 of Exhibit K, the changes shall automatically apply to and modify all existing interconnection agreements that currently contain Exhibit K, the QPAP, as an exhibit.
