TO ALL INTERESTED PERSONS:

This letter is to inform you of a planned change in content for the adoption hearing previously noticed for March 14, 2001; to request comment on a revised access to premises rule; and to notify you of an opportunity to attend a workshop on a draft access to premises rule.

A. <u>Proposed Rule Adoption Hearing—Exclusion of WAC 480-120-049, Access To Premises</u>

As previously noticed, the Commission will consider adoption of several sections of Chapter 480-120 WAC at its March 14 Open Meeting. The meeting will begin at 9:30 A.M. on Wednesday, March 14, 2001 and the Commission will consider adoption of the rules published in the Washington State Register #01-03-100 on January 19, 2001.

Staff will recommend to the Commission that it adopt the rules as printed, with the exception of proposed WAC 480-120-049, Access to premises. Staff has prepared an alternative to the proposed rule and is seeking comment on the alternative draft rule.

B. Opportunity to Submit Written Comment on Access To Premises Draft Rule

Enclosed with this notice is a draft rule concerning access to premises. This draft was prepared by staff as an alternative to the proposed Access to Premises rule. Comment is sought on the policy and legal issues raised by this draft and examples of the effect of exclusionary or restrictive agreements in the multi-tenant environment.
