Dear Ms. Washburn:

In Order No. 8 in the above-entitled docket the Commission determined that the VoIP service provided by LocalDial Corporation is a telecommunications service subject to the Commission's jurisdiction. The Commission ordered LocalDial to cease and desist from providing intrastate telecommunications service in Washington as of midnight, June 21, 2004, unless and until it thereafter registers with the Commission.

LocalDial has concluded that it is not possible for the company to both comply with Order No. 8 and stay in business. Accordingly, and in compliance with the Commission's Order No. 8, LocalDial has ceased providing all VoIP services, both intrastate and interstate, to its customers in all states in which the company has been operating. In order to avoid disruption to its customers, LocalDial has arranged to switch its customers to Marathon Communications, a telecommunications company that is registered with the Commission.
