a) I ask for a hearing for a decision by an administrative law judge



RCW 9A.72.020:

“Perjury in the first degree. (1) A person is guilty of perjury in the first degree if in any official proceeding he makes a materially false statement which he knows to be false under an oath required or authorized by law. (2) Knowledge of the materiality of the statement is not an element of this crime, and the actor’s mistaken belief that his statement was not material is not a defense to a prosecution under this section. (3) Perjury in the first degree is a class B felony.”

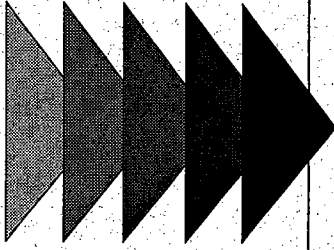

To Whom It May Concern:

We recently received a notice of penalties incurred and due for violations of laws and rules (copy enclosed) stating that we have been assessed a \$100 penalty for late filing of our annual report. The notice states that we failed to file our annual report by May 1 and states that we have the right to contest this penalty.

We are enclosing copies of our certified mail receipt showing that we mailed the report on May 1 and that you received it on May 2. We have always mailed our annual reports on May 1 and have never previously had a penalty. We have been told that the reports are now expected to be received by May 1, but no one ever informed of us this change. It is our belief that the report was filed in a timely manner and in the manner which had been acceptable in prior years and that the penalty should be abated.
