TO: The Executive Secretary, Washington Utilities and Transportation Commission

1 The parties below, through counsel, file this joint status report to update the Commission on their continuing settlement discussions. After a series of email exchanges and initial document review, the parties are now proposing a meeting with the members of the Transportation Staff of the Commission to attempt to review chronology and background of issuance and amendment of the respective auto transporter certificates, removal of restrictions, geographic service areas and tariff publication history which comprise the gist of the complaint. The parties believe that this matter should first be addressed in a joint meeting with Commission Staff prior to proceeding to any adversarial hearing on the matter. The parties are seeking to identify a mutually available date, subject to Staff availability. In any event, the parties hope the meeting can be completed over the next month and ask that deferral and further status report continue until June 30 to accommodate this scheduling.


