SETTING TIME FOR ORAL STATEMENTS (Set for November 19, 2018, at 1:30 p.m.)

- On September 10, 2018, Bremerton Kitsap Airporter, Inc. (BKA or Company) filed with the Washington Utilities and Transportation Commission (Commission) Time Schedule #24 and revisions to its currently effective Tariff 10, designated as Fourth Revised Title Page, Eighth Revised Page 1, Tenth Revised Page 2, Seventh Revised Page 3, Eighth Revised Page 4, and Ninth Revised Page 5. The stated effective date is October 1, 2018. Time schedule #24 adds a new stop at the Holiday Inn Express located at 11751 Pacific Highway SW, Lakewood; the other tariff revisions constitute administrative changes to tariff rule language and do not affect rates.
- Pacific Northwest Transportation Services, Inc. d/b/a Capital Aeroporter Tours and Charters, (Capital Aeroporter) contacted Staff with concerns about the Company's Time Schedule #24 and Time Schedule #24 Original Page 1 because the Holiday Inn Express falls within its territory. The Commission construes Capital Aeroporter's stated concerns as an objection to the Company's proposal pursuant to WAC 480-30-136.¹

¹ The Commission liberally construes pleadings and motions to effect just results. WAC 480-07-395(4).

The matter was heard by the Commission at its regularly scheduled open meeting on September 27, 2018.

- On September 27, 2018, the Commission entered Order 01, Complaint and Order Suspending Proposed Time Schedule; Allowing Tariff Revisions to Become Effective by Operation of Law (Order 01). Order 01 suspended Time Schedule #24 and Time Schedule #24 Original Page 1, and stated that the Commission would hold a hearing regarding the proposed time schedules.
- Pursuant to RCW 34.05.482, WAC 480-07-610, WAC 480-30-140, and WAC 480-30-136 the Commission determines that a brief adjudicative proceeding is appropriate for resolving the issues in this matter.
- THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 1:30 p.m., on Monday, November 19, 2018, in Room 206, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.
- The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.
- Written notice of any other stage in the proceeding or other formal proceedings that the Commission may deem appropriate will be given during the course of this case. The Commission will provide at its offices in Olympia, Washington, copies of documents in the current record for use by the parties or others who may want to review them.
- In accordance with WAC 480-30-136(2), the Commission requests that the parties file by **noon, November 13, 2018**, the following additional documents for consideration at the brief adjudicative proceeding:
 - (1) Statements from independent witnesses provided by an objecting company to demonstrate that the objecting company is providing the same service as the proposed service, to the satisfaction of the commission.
 - (2) Statements from independent witnesses provided by an objecting company to demonstrate that the traveling public will be harmed by the granting of the application.
 - (3) Additional supplementary information, evidence or testimony provided by the applicant to demonstrate that public convenience and necessity requires the proposed service.

The Commission also requests that each party file an exhibit list enumerating and describing all documents the party intends to offer at hearing **no later than noon on Tuesday, November 13, 2018.** Filing shall be in accordance with WAC 480-07-140.

- THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the brief adjudicative proceeding set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.
