TO ALL INTERESTED PERSONS:

On May 30, 2024, PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp) filed with the Washington Utilities and Transportation Commission (Commission) a report detailing the eligible renewable resources acquired for complying with their respective 2024 renewable resource targets.

On May 31, 2024, Avista Corporation d/b/a Avista Utilities (Avista) and Puget Sound Energy (PSE) filed with the Washington Utilities and Transportation Commission (Commission) reports detailing the eligible renewable resources acquired for complying with their respective 2024 renewable resource targets.

These reports are required by the Energy Independence Act, Chapter 19.285 RCW, and WAC 480-109. WAC 480-109-210(3) provides that Commission Staff and all interested persons may comment on the utility's annual renewable portfolio standard report within 30 days of the utility's filing. The Commission will consider the reports and any comments it has received at a future open meeting.

Comments should include:

1. **PDF:** Upload/email your comments in .pdf form.
2. **Docket Number:** The docket number (UE-240241, UE-240405, or UE-240411). The docket number is like a case number used by Commission Staff to keep records on a specific filing.
3. **Name:** Include your full name.
4. **Title and Date:** Include the title and date of the comment or comments.

Open Meeting Comments:

- **Oral Comments:** If you don't provide written comments, you will still be able to make oral comments if this item is brought up at an open meeting.

The Commission will consider all comments and determine whether additional scrutiny is warranted and may establish an adjudicative proceeding or other process to fully consider appropriate revisions. Upon conclusion of its review of the renewable resource standard reports, the Commission will issue a decision determining whether the companies correctly calculated their 2024 renewable resource targets and complied with their reporting requirements.
