RE: Developing a Commission jurisdictional specific cost-effectiveness test for distributed energy resources incorporating CETA, Docket UE-210804

TO ALL INTERESTED PERSONS:

On November 8, 2021, the Washington Utilities and Transportation Commission (Commission) issued a Notice of Opportunity to File Written Comments in Docket UE-210804 soliciting feedback from interested persons on Commission staff's (Staff) investigation to determine whether additional guidance related to the cost-effectiveness of distributed energy resources (DERs) is necessary. Staff intends to develop a jurisdiction-specific test for DERs that incorporates the goals of the Clean Energy Transformation Act. Staff's investigation will follow the process and principles described in the <u>National Standard Practice Manual For Benefit-Cost Analysis of Distributed Energy Resources</u> (NSPM). The Commission received comments from ten stakeholders. The Commission will convene a two-hour virtual workshop on Tuesday, May 10, 2022, at 10:30 a.m. to address stakeholder feedback.

A workshop agenda will be issued in Docket UE-210804 prior to the meeting date and distributed to interested persons. The workshop will be led by Commission staff.
