QWEST CORPORATION'S MOTION FOR  
CORRECTION OF OS/DA FINAL ORDER

Qwest Corporation hereby moves the Commission to correct its OS/DA Final Order<sup>1</sup> to reflect the parties' stipulation regarding modification of paragraph 183 of the Recommended Decision.<sup>2</sup> This motion is made pursuant to WAC 480-09-815.

Paragraph 183 of the Recommended Decision provided that "[i]f Tel West orders blocking or screening services to avoid incurring OS/DA charges, then Qwest must either remove those charges from Tel West's account or not bill them in the first instance." In its Comments on the Recommended Decision, Qwest requested the Commission on administrative review to modify paragraph 183 by adding the following language after the words "in the first instance": "unless Tel West is responsible for deactivating Dial Lock or otherwise permitting the service to become inoperable, ineffective or under the

1 control of a third party.” *Qwest’s Comments on Recommended Decision, at 11-12.*

2 At the May 8, 2002 open meeting oral argument, Tel West stipulated on the record to the  
3 suggested modification to paragraph 183 and the Commission indicated its approval. *Transcript (May*  
4 *8, 2002), at 00480, lines 4-17.*<sup>3</sup> The OS/DA Final Order does not reflect the parties’ stipulated  
5 modification to paragraph 183 and should thus be corrected pursuant to WAC 480-09-815.
