BACKGROUND

I On October 30, 2020, Avista Corporation, d/b/a Avista Utilities, (Avista or Company) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective electric and natural gas service tariffs, Tariffs WN U-28 and WN U-29, in Dockets UE-200900 and UG-200901 that are designed to effect a general rate increase for its electric and natural gas services (general rate case, or GRC), and also an accounting petition in Docket UE-200894 for costs associated with its wildfire resiliency plan (Petition). On December 23, 2020, the Commission entered Order 04/01, consolidating the three dockets.

2 On May 27, 2021, Avista filed with the Commission a Motion to Amend Procedural Schedule and Accept Partial Multiparty Settlement Stipulation (Motion). Avista appended to its Motion the Partial Multiparty Settlement (Settlement) and Attachment A to the Settlement. Avista represented in its Motion that no party objects to amending the procedural schedule.

DISCUSSION AND DECISION

- Avista's Motion requests that the Commission modify the procedural schedule to require the filing of joint or separate testimony in support of the Settlement by Avista, Commission staff (Staff), the Alliance of Western Energy Consumers (AWEC), the Inland Empire Paper Company (Inland Empire), the Energy Project, and Sierra Club (Settling Parties) by June 25, 2021. The Motion also requests that the procedural schedule be modified to allow for the filing of an executed Special Contract between Inland Empire and Avista by June 25, 2021. Last, the Motion requests that the Settlement and the Special Contract be addressed at the evidentiary hearing already scheduled for July 7 and 9 (if necessary), 2021. All other procedural dates would remain the same. Public Counsel, the only party who has not joined the Settlement as of yet, does not object to the Motion's requests to amend the procedural schedule.
- We find the proposed modifications to the procedural schedule reasonable. It is appropriate to address the proposed Settlement, in addition to any fully contested issues, during the currently scheduled virtual evidentiary hearing set for July 7, 2021, beginning at 9:30 a.m. and continuing on July 9, if necessary. The proposed date of June 25, 2021, for filing supporting testimony and also the Special Contract between Inland Empire and Avista is also reasonable. An updated procedural schedule, showing the modifications approved by this order, is attached to this Order as Appendix A. Accordingly, we determine that Avista's motion to amend the procedural schedule should be granted as requested.

ORDER

THE COMMISSION ORDERS:

5 Avista Corporation's, d/b/a Avista Utilities, motion to amend the procedural schedule is GRANTED.
