Pursuant to WAC 480-123-060, U. S. Cellular Corporation ("USCC") hereby submits one copy of its 2006 WA FCC Complaints, 2006 WA AG Complaints, and updated Exhibit K to supplement its annual recertifications and reports filed July 30, 2007. USCC was also asked to confirm Exhibit B to its report, the outage report. This request is still being investigated.
