AT&T/GTE Interconnection Agreement

Cross Reference of Arbitrator's Decision to Contract Provisions

The Interconnection Agreement dated March 4, 1997 (the "Agreement") which accompanies this guide has been marked by AT&T to indicate whether the provisions contained therein are "arbitrated" or "negotiated." This was prepared by AT&T and will be reviewed by GTE at the time it is filed with the Washington Utilities and Transportation Commission.

The summary below provides cross-references showing the relationship between the decision points in the Arbitrator's Decision and Order dated December 11, 1996 and the specific provisions of the Agreement which relate to such decision points. The summary below also indicates which party prevailed on the issue. There may be broader provisions which relate to specific decision points, but for ease of reference those broad references have generally been omitted from this guide.

There are instances where the parties have agreed on certain issues which were decided differently by the Arbitrator. In these instances, the language is indicated as negotiated (rather than arbitrated) and the summary below cites the provision(s) of the Agreement reflecting the parties' negotiation.
