NOTICE OF OPPORTUNITY TO RESPOND TO PETITIONS FOR RECONSIDERATION AND MOTION FOR CLARIFICATION (Responses due by February 13, 2025)

and

NOTICE SPECIFYING THE DATE BY WHICH THE COMMISSION WILL ACT ON THE PETITIONS FOR RECONSIDERATION AND MOTION FOR CLARIFICATION (By March 17, 2025)

RE: *Washington Utilities and Transportation Commission v. Puget Sound Energy,* Dockets UE-240004, UG-240005 and UE-230810 (Consolidated),

TO ALL PARTIES:

On February 15, 2024, Puget Sound Energy (PSE) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective Tariff WN U-60, Tariff G, Electric Service, and its currently effective Tariff WN U-2, Natural Gas.

On January 15, 2025, the Commission entered Order 09/07 Final Order (Order 09/07).

On January 24, 2025, PSE filed a Petition for Reconsideration of Order 09/07.

On January 27, 2025, the Alliance of Western Energy Consumers (AWEC) and The Energy Project (TEP) filed a Petition for Reconsideration of Order 09/07. Further, on January 27, 2025, Joint Environmental Advocates (JEA) filed a Motion for Clarification and Petition for Reconsideration. Also on January 27, 2025, NUCOR Steel Seattle, Inc. (NUCOR) filed a Petition for Reconsideration of Order 9/07.

Pursuant to WAC 480-07-850, the Commission now authorizes all parties to respond to the Petitions by 5 p.m. on February 13, 2025.¹

Additionally, pursuant to WAC 480-07-850(2)(b), the Commission gives notice that it will consider the Petitions and Responses and issue a decision by Monday, March 17, 2025.

The Commission authorizes each party to file one Response addressing one or all of the Petitions and the Motion in the Response. The Response shall be no more than twenty (20) pages in length.

THE COMMISSION GIVES NOTICE That the Commission authorizes parties to submit responses to the Petitions for Reconsideration and the Motion for Clarification by 5 p.m., Thursday, February 13, 2025.

THE COMMISSION GIVES FURTHER NOTICE That the Commission will issue a decision on the Petitions for Reconsideration by Monday, March 17, 2025.
