Pursuant to Article 7.1 of the Washington Extended Interim Participatory Funding Agreement ("IPFA") approved by the Washington Utilities and Transportation Commission ("Commission") in Order 02 in Docket U-210595, the Alliance of Western Energy Consumers ("AWEC") hereby requests final payment of AWEC's Puget Sound Energy Customer Representation Sub-Fund Grant in the amount of \$73,897.00.

On February 15, 2024, Puget Sound Energy, ("PSE" or the "Company") filed its request for a general rate revision for its electric and natural gas service. The Commission docketed these filings as UE-240004 and UG-240005. On March 5, 2024, the Commission issued Order 01 in this proceeding, consolidating Dockets UE-240004 and UG-240005; on March 29, 2024, the Commission issued Order 03/01 consolidating Docket UE-230810 with the general rate case.

PAGE 1 – AWEC'S REQUEST FOR PAYMENT OF SUB-FUND GRANT

On February 26, 2024, as required by Article 6.2 of the IPFA, AWEC filed its

request for Case Certification and Notice of Intent to Request a Fund Grant, which was also

served on PSE and all parties of record in the proceeding. In that filing, AWEC identified the

PSE Customer Representation Sub-Fund as the account from which AWEC intended to request a

Fund Grant.

On May 2, 2024, AWEC filed a Proposed Budget with the Washington Utilities

and Transportation Commission ("Commission"), requesting a Fund Grant of \$68,897.00 from

the PSE Customer Representation Sub-Fund to partially offset the costs of AWEC's participation

in this proceeding. On May 15, 2024, AWEC's request for Case Certification and its Proposed

Budget were approved by the Commission in Order 06/04 in the full amount of \$68,897.00.

On June 14, 2024, pursuant to Article 4.2.4 of the IPFA, AWEC filed a Petition to

Increase Customer Representation Sub-Fund by \$5,000 to offset the cost of procuring an Aurora

license to audit PSE's power costs. As stated in that petition, all affected parties supported

AWEC's petition to increase the Customer Representation Sub-Fund to account for the cost of

the Aurora license. 1 As of the filing of this Request for Payment, the Commission has not ruled

on AWEC's petition to increase the Customer Representation Sub-Fund. Accordingly, AWEC

requests that the Commission approve that petition concurrently with any decision to approve

AWEC's Request for Payment.

¹ AWEC Petition to Increase Customer Representation Sub-Fund ¶ 4 (June 14, 2024). AWEC's Petition also noted that PSE did not support AWEC's position that, in the future, the cost of power modeling licenses should be borne

by utilities, not customers. Id.

PAGE 2 – AWEC'S REQUEST FOR PAYMENT OF SUB-FUND GRANT

At this time, AWEC requests that the Commission approve its Petition to Increase

the Customer Representation Sub-Fund and authorize final payment of AWEC's approved Sub-

Fund Grant in the amount of \$73,897.00 from the 2024 PSE Customer Representation Sub-Fund.

This Request for Payment satisfies the requirements of the IPFA as follows:

<u>Article 7.1(a)</u> – The itemized expenses, payees, and hourly rates – including

separately identified amounts for consultant or expert witness fees and travel

expenses – are attached as Confidential Exhibit A.

<u>Article 7.1(b)</u> – AWEC has been an active participant in this Proceeding. AWEC

reviewed the filings in this Proceeding, conducted discovery, filed testimony,

participated in settlement discussions, participated in the evidentiary hearing, and

filed a brief. The expenses included in Confidential Exhibit A are reasonable and

directly attributable to AWEC's participation in Dockets UE-240004 and UG-

240005.

<u>Article 7.1(c)</u> – As set forth in this Request for Payment, AWEC has provided

information sufficient to demonstrate that AWEC has complied with all

conditions and requirements of its approved Sub-Fund Grant.

<u>Article 7.1(d)</u> – This Request for Payment constitutes a Request for Final

Payment for the full amount of AWEC's approved budget in this Proceeding

(assuming AWEC's Petition to Increase the Customer Representation Sub-Fund is

approved).
