In April, Commission Staff recommended a smaller overall electric revenue increase of $\$ 7.2$ million and a natural gas overall revenue increase of $\$ 5.6$ million. Both proposals would offset the proposed rate increase with a pass-back of tax benefits.

Under Staff's proposal, an average residential customer, electric customer, using 914 kilowatt hours a month would pay 89 cents less for an average monthly bill of $\$ 81.44$, a 1.1 percent decrease. A typical natural gas customer using 67 therms per month would pay 11 cents less for an average monthly bill of $\$ 56.42$ or 0.2 percent decrease.

The three-member Commission is knocked down by Staff's recommendation. You will have the opportunity this evening to provide your comments to the Commissioners pertaining to this case.
