On May 20, 2005, Douglas and Jessica Rupp, Kathie Dunn and Chris Hall; Michelle Lechuga, Verlin Jacobs, Anthony Williams, Christine and Samuel Inman, Robert Jacobs, and Sam Haverkemp and Chris Portrey (Petitioners) filed with the Commission a formal complaint against Verizon Northwest Inc. (Verizon). On June 13, 2005, Verizon filed an answer to the complaint and a motion to dismiss the petition for order to extend service area of respondent. The complaint alleges that Verizon refuses to extend its service area to include properties owned by Petitioners in and near Skyko 2. A more detailed account of the dispute is reflected in the complaint, which is available for inspection at the Commission's office located at Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington, and on the Commission's web site at <a href="https://www.wutc.wa.gov/050778">www.wutc.wa.gov/050778</a>. It is appropriate that the matters raised in the pleadings be brought for hearing before the Commission.

The Commission will hear this matter pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.434, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, having legal authority to regulate the rates, services, and practices of telecommunications companies providing service within the state of Washington. Statutes and rules cited in the complaint include RCW 80.36.040, RCW 80.36.090, RCW 80.36.170, RCW 80.36.230, RCW 80.36.240, RCW 80.36.260, RCW 80.36.300, WAC 480-120-071, 47 USC 214, and 47 USC 254. Statutes involved, in addition to those previously cited, include those within chapters 80.01 RCW, 80.04 RCW, 80.36 RCW, 480-07 WAC, and 480-120 WAC, including but not limited to RCW 80.01.040 and RCW 80.04.020.

- The ultimate issues involved are generally stated above and more specifically contained in the complaint.
- THE COMMISSION GIVES NOTICE That a prehearing conference in this matter will be held at 1:30 p.m. on Wednesday, July 20, 2005, in Room 206, Chandler Plaza Building, 1300 S. - The purpose of the prehearing conference is to take appearances and interventions, establish dates for the distribution of evidence and workpapers and other scheduling matters, consider formulating the issues in the proceeding and to determine other matters to aid in its disposition, as specified in WAC 480-07-430.

Petitions to intervene should be made in writing at least three business days prior to the date scheduled for the prehearing conference, as required in WAC 480-07-355(a).
