Dear Mr. King:

i-wireless, LLC hereby provides notice of changes to its Lifeline offering effective December 1, 2018 in accordance with changes in the Federal Communications Commission's minimum service standards set forth at 47 C.F.R. § 54.408.

As summarized in Attachment A attached hereto, i-wireless' non-tribal voice plans will increase from 750 voice minutes to 1,000 voice minutes each month, still with unlimited text messages and 50 megabytes (MB) of data (500 MB for legacy customers enrolled prior to Feb. 1, 2018) at a net cost of \$0.00 per month after Lifeline support. Existing customers on the non-tribal broadband plan prior to December 1, 2018 will migrate to the updated Legacy Plan, and i-wireless' updated broadband plan option will include 2 gigabytes (GB) of data, with access to voice and text services via purchased Top Up options starting at \$5.00. There are no changes to the Tribal plan option.
